BOARDING AGREEMENT

This is a contract between **BEST FRIENDS - BREEDING & BOARDING** and the pet Owner. **BEST FRIENDS - BREEDING & BOARDING** agrees to exercise due and reasonable care, and to keep the **BEST FRIENDS - BREEDING & BOARDING** premises sanitary and properly enclosed. The dog(s) is (are) to be fed properly and regularly, and to be housed in clean, safe quarters. All dogs are boarded or are otherwise handled or cared for by **BEST FRIENDS - BREEDING & BOARDING** staff without liability on **BEST FRIENDS - BREEDING & BOARDING** part for loss of damage from disease, theft, fire, death, escape, injury or harm to persons, other dogs or property by said dog(s), or for other unavoidable causes, due diligence and care having been exercised..... **Initial**

If the pet(s) becomes ill or if the state of the animal's health otherwise requires professional attention, **BEST FRIENDS - BREEDING & BOARDING**, in its sole discretion, may engage the services of a veterinarian of its choosing, or administer medicine, or give other requisite attention to the animal, and expenses thereof shall be paid by Owner. **Initial**

Daily boarding charge begins the day your dog arrives to our facility. Owner agrees to notify **BEST FRIENDS - BREEDING & BOARDING** in advance if there is any change in the date this boarding animal is to be picked up. Owner understands and agrees that dog(s) picked up by Owner after 9:00 A.M. shall be charged for a full day's stay. Clients may pay in full the cost for the scheduled boarding up front. Any additional charges incurred by Owner shall be payable upon pickup of pet(s). Owner further agrees that pet(s) shall not leave **BEST FRIENDS - BREEDING & BOARDING** until all charges are paid to **BEST FRIENDS - BREEDING & BOARDING** by Owner. **BEST FRIENDS - BREEDING & BOARDING** shall have, and is hereby granted, a lien on the pet(s) for any and all unpaid charges resulting from boarding pet(s) at **BEST FRIENDS - BREEDING & BOARDING**. If for any reason you cannot pick up your pet on the scheduled date, you must call to advise of alternate pick up date. Owner shall remain liable for complete boarding bill as well as all other charges incurred in the care, and maintenance of said pet(s) as listed on this agreement..... **Initial**

The owner of the animal or his designee agrees to pay for reasonable attorney's fees incurred by **BEST FRIENDS - BREEDING & BOARDING** in the collection of any outstanding fees or other charges incurred by the owner of the animal. **Initial**

It is understood by **BEST FRIENDS - BREEDING & BOARDING** and Owner that all provisions of this Contract shall be binding upon both parties thereunto for this visit and for all subsequent visits. This Contract contains the entire agreement between both parties:
